AGREEMENT OF RELEASE

1. HEREBY RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE M.T.P.A. AS AN ASSOCIATION, INCLUDING ALL ITS ELECTED AND APPOINTED OFFICIALS, ALL MEMBERS OF COMMITTEES, INSPECTORS, ITS INDIVIDUAL MEMBERS, ITS MEMBER CLUBS, ANY RENTAL SLED COMPANY, AND/OR SLED OWNER, PROMOTER OR FACILITY WHICH CONTROL ESSENTIAL EVENT SITES, AND FIRMS WHICH RENDER ESSENTIAL GRATIS, INCLUDING ALL OFFICERS, AGENTS, EMPLOYEES OF THE FOREGOING, AND VOLUNTEER WORKERS ASSISTING IN SANCTIONED M.T.P.A. EVENT ACTIVITIES, ALL HERINAFTER REFERRED TO AS "Releases" from or for any and all liability to me, my personal representatives, heirs, next of kin, successors, and assigns, for all loss or damage for bodily injury, or death or M.T.P.A. event activity or part thereof, during the actual sanction period and whether any such claim may be based upon alleged breach of any statutory duty or obligation: and
2. HEREBY AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releases and each of them from any loss, liability damage or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releases or otherwise.
3. HEREBY ASSUME FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to negligence of releases or otherwise while in or upon the restricted area, and/or while competing, officiating, observing, working, or working for any purpose participating in the event.
4. EXPRESSLY ACKNOWLEDGES AND AGREES THAT THE ACTIVITIES OF THE EVENT ARE VERY DANGEROUS AND INVOLVE THE RISK OF SERIOUS INJURY AND/OR DEATH AND/OR PROPERTY DAMAGE, THE UNDERSIGNED further expressly agrees that the foregoing RELEASE WAIVER and INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by the law of the Province or State which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect.
5. EXPRESSLY ACKNOWLEDGES AND AGREES THAT any one person that is ruled to be Abusive and/or Threatening (physically and/or verbally) and/or Detrimental to the M.T.P.A. AS AN ASSOCIATION, INCLUDING ALL ITS ELECTED AND APPOINTED OFFICIALS, ALL MEMBERS OF COMMITTEES, INSPECTORS, ITS INDIVIDUAL MEMBERS, ITS MEMBER CLUBS ANY RENTAL SLED COMPANY AND/OR SLED OWNER, PROMOTER OR FACILITY WHICH CONTROL ESSENTIAL EVENT SITES, AND FIRMS WHICH RENDER ESSENTIAL GRATIS, INCLUDING ALL OFFICERS, AGENTS, EMPLOYEES OF THE FOREGOING, AND VOLUNTEER WORKERS, ASSISTING IN SANCTIONED M. T.P.A. EVENT ACTIVITIES, ALL HERINAFTER REFERRED; if ruled Abusive and/or Threatening and/or Detrimental by M.T.P.A. the first offense will result in being given a verbal warning by the M.T.P.A. Thereafter if a second offense occurs and is ruled to be Abusive and/or Detrimental by the M.T.P.A. Thereafter will be barred from being and/or becoming a member and/or participating in any of the M.T.P.A. events.
6. EXPRESSLY ACKNOWLEDGES AND AGREES THAT M.T.P.A. Reserves the right to refuse membership to any one person at any time.
7. EXPRESSLY ACKNOWLEDGES AND AGREES TO abide by any and/or all decisions or rulings made by the Board Members and/or Officials of the M.T.P.A.
8. EXPRESSLY ACKNOWLEDGES AND AGREES THAT said pulling vehicle to the best of driver(s) and/or owner(s) knowledge conforms to meet all current M.T.P.A. rules and/or regulations. This includes all individual class rules and/or regulations, all general rules and/or regulations, and all safety rules and/or regulations set in place by the M.T.P.A.
